NOTICE IS HEREBY GIVEN
that pursuant to the resolution
duly adopted by the Board of
Fire Commissioners of the
Town of Mohawk Fire District,
in the Town of Mohawk,
Montgomery County, New
York, on November 8, 2021
a Special Referendum at
the Special Election of the
qualified voters of said Fire
District will be held at the Fire
Station located at 2553 State
Highway 30A in the Town
of Mohawk, Montgomery
County, New York, in said
Fire District, on December
21, 2021 at 6:00 o'clock P.M.
(Prevailing Time) and the
polls to remain open until
9:00 o'clock P.M. (Prevailing
Time) or as much longer as
may be necessary to enable
the voters then present to
cast their votes to vote upon
the following Proposition:

SHALL the Resolution

November 8, 2021, en-
titled: "A RESOLUTION
AUTHORIZING THE BOARD

NEW YORK, TO (1)
PURCHASE A FIRE
ENGINE/RESCUE TRUCK
FOR A TOTAL PRICE NOT
TO EXCEED \$725,000.00,
(2) ISSUE SERIAL BONDS
IN AN

AGGREGATE PRINCIPAL
AMOUNT NOT TO EXCEED
\$450,000.00 TO FINANCE
THE BALANCE OF THE
COST OF THE FIRE
ENGINE/RESCUE TRUCK,
(3) DELEGATE THE
POWER TO ISSUE SERIAL
BONDS IN AN AGGREGATE
PRINCIPAL AMOUNT NOT
TO EXCEED \$450,000.00
TO THE TOWN OF
MOHAWK FIRE DISTRICT
TREASURER, AND (4) LEVY
TAXES TO BE COLLECTED
TO PAY FOR THE
PRINCIPAL AND INTEREST
ON THE SERIAL BONDS
HEREBY AUTHORIZED," be

Election shall be eligible to
vote.
